#### **HMIP Meeting**

AYM representatives recently met with Helen Mercer, HM Assistant Chief Inspector, HMIP (on the right in the photo). We used to meet regularly with Alan MacDonald, and Helen has taken on this task. She is known to us from her time at the YJB, and before that in YOTs.

As always, it was a fruitful meeting. Helen has confirmed that the next Thematic will be on out of court disposals, with fieldwork due to start this summer following preparation and consultation.





The new inspection regime will begin in 2018/19, which has been delayed due to the Charlie Taylor report's recommendation that Ofsted inspect YOTs. This has not been accepted by government, and so HMIP will continue to be our inspectorate. The SQS regime is now complete, and the last FJI was completed in March.

Marius Frank (at left in photo) joined the meeting to present the SEND project we are running in conjunction with him and Ambition for All. He shared the progress so far, including the findings of research with young people at YOTs. One of the points he made was that some young people are only being identified as SEN following contact with YOTs. He quoted our SLCN lead, Diz Minnit, that we should screen

young people out of being SEN, rather than screening them in – which would be a welcome fundamental change of emphasis.

The meeting was hosted by our Chair, Lesley Tregear, at the Warwickshire Justice Centre in Leamington Spa. This innovative initiative colocates court and justice services in a building designed to fit the needs of a wide variety of users and staff.



# ILM 7 Certificate in Leadership & Management starts soon



The YOT Manager specific ILM 7 course with Solace is starting in May, and will run until October. A small number of places are still available. We will report back on progress later in the year.



#### **Sport & ASB Bid**

AYM is supporting a bid to the Police Transformation Fund to reduce ASB. The bid is being led by Derbyshire PCC, along with the national charity StreetGames.

Hazel Williamson, AYM Regional Representative for West Midlands, is actively involved in the bid on our behalf.

The partnership consists of PCCs, Police Services, Network Rail and British Transport Police, Sport England, the YJB and AYM. It will develop an evidence-based framework to support the management and design of sports-based interventions that are both effective and offer value for money. The Framework aims to demonstrate effective interventions to:





- reduce ASB and low level offending;
- promote a better relationship between the Forces and hard to reach youth and communities;
- contribute to effective early intervention strategies;
- provide opportunities for community referrals to quality assured community sports clubs.

## **Exclusions Consultation – AYM needs your views**



DfE are launching a consultation on revisions to the 2012 statutory guidance on the exclusion of pupils, to make the rules clearer, and to provide greater confidence and clarity for those involved in the exclusion process. The proposed amendments do not change the rights of, or requirements on, schools, children or parents over exclusion.

Within the consultation, DfE have made several updates (such as including references to Education, Health and Care plans to reflect the Children and Families Act 2014) and clarifications (such as over the role of the SEN expert at an Independent Review Panel).

This will be an area of interest to YOTs, given the education issues our young people face. Some of the proposed changes relate to SEND, so this is very topical given our work with Ambition for All and Manchester Metropolitan University. AYM is pulling together a response, led by Phil Sutton.

### **SEND Year 1 Success & Year 2 Planning**

Over the last few weeks the project team have been working towards an agreement with DfE, YJB and MoJ on the priority activities for the second year of the project.

#### They plan to:

- Work with around 35 YOTs and local authorities to support improvements in practice using the project's Ten Key Statements of Effective Practice in SEND, and the Peer Improvement Process piloted by Leeds and Cheshire.
- Deliver initial training at each of the youth justice secure establishments (YOIs, STCs and SCHs).
- Continue to develop the Youth Justice SEND Bubble (e-learning) and open it up to a wider audience including police, magistrates and panel members. See https://yiresourcehub.uk
- Work with 5 YOTs and local authorities on a research project exploring how information collected by schools, local authorities and others can be used more effectively to help prevent young people entering the youth justice system.
- Run an additional workshop in Birmingham as a sweep up session for colleagues who could make one of the earlier dates. Central Government is keen for the project to target YOTs/ LAs in areas of high deprivation and/or high volume of first time entrants to make best use of its limited funding. AYM will be in contact with YOTs over the next month to discuss their engagement in this phase of the project.

Over 130 YOTs in England have engaged with the project over the first year, and our roadshows were attended by around 400 colleagues. The project team are grateful for this fantastic level of interest, and for the great support from our Advisory Group which has representatives from YOTs in Cornwall, Essex, Milton Keynes, Kirklees, Buckinghamshire, Leeds and NE Lincs.

#### **AYM Feedback from SCYJ Committee Meeting**

Our AYM Secretary, Ian Langley, attended the SCYJ Committee Meeting this month.

Laura Beaumont, Deputy Director of the Youth Justice Unit at the MoJ spoke of the MoJ response to the Taylor report.

This sparked considerable debate about the Prison and Courts Bill, especially HMCTS seeking reforms in court appearances. Increasing the use of video court hearings for young people was strongly opposed by the Committee, as was entering pleas online. This approach misses the communication needs of young people and their ability to receive justice. SCYJ are preparing a briefing on the Bill, to be published soon. AYM would welcome hearing your views – please email them to jon.obyrne@aym.org.uk

The Committee also heard from Patrick Kinsella of the Traveller Movement about their work, including their recent success in improving ethnic monitoring for the Gypsy and Irish Traveller and Roma communities.




#### **Policing Strategy for Children & Young People**



# Sentencing Council publishes new guidance

The Sentencing Council has published its definitive guidance for children and young people, which includes new offence specific guidelines on robbery and sexual offences.

It aims to provide up-to-date, comprehensive and accessible guidance on the general principles to be applied when sentencing children and young people. It takes the form of a new overarching principles guideline and new offence specific guidelines on robbery and sexual offences.





The guidelines will come into force on 1 June 2017.

### Research Opportunity - Women and Girls in the CJS

Would you like to contribute to practice and policy debates about women offenders by undertaking your own pioneering research?

The Griffins Society promotes effective practice in working with women and girls who are in prison or subject to criminal justice interventions in the community.





Griffins Research Fellows carry out their year-long research projects alongside their employment; they receive support from the Society and from the Institute of Criminology, University of Cambridge; the Society provides a modest research grant and travel bursary and helps to promote findings at the end of the Fellowship.

Previous research experience or a degree is not necessary, although applicants must be capable of studying and writing at or near degree level.

Six Fellowships are available for 2017-18, five of which can be on any aspect of the treatment of women or girls in the criminal justice system. The other is being offered in conjunction with the Barrow Cadbury Trust which is an independent, charitable foundation committed to bringing about a more just and equal society. For this fellowship, they are seeking proposals relating specifically to the treatment of young adult women (those aged between 18 and 25, which may include the transition between youth and adult systems).
