News from the AYM Executive Board



We all hope you have been having a good summer, members of our Executive Board have been taking their annual summer leave but work continues with meetings with stakeholders, even though parliament has been in recess.

Working with external stakeholders

Nick Jeffreys and Jessica Edwards attended a meeting hosted by the Alliance for Youth Justice (AYJ) this month in which concerns regarding youth custody were discussed. Organisations at the meeting expressed concerns regarding conditions and regimes and the treatment of children in custody expressing serious concerns about discrimination, lack of education provision and the isolation of children locked in their cells for 23 hours per day. There was a view that the conditions have been normalised and the meeting was keen to ensure improvements are implemented.



The meeting also discussed concerns raised at the recent AYM conference regarding the proposed use of PAVA spray, the use of dogs to maintain control and the impact on those establishments who now also hold children aged 18 years.

Nick and Jessica advised the meeting that the experiences of youth justice services regarding the treatment of children they supervise in custody is continually raised with Safeguarding Partnerships who hold responsibility for secure establishments in their local authority, and consideration is given to raise freedom of information requests in those areas with youth offending institutions.

The AYM will be considering at their next Executive Board meeting how it can co-ordinate concerns further – through a survey of views regarding the placement of 18-year-olds in the youth estate and a review of the observed responses to urgent notifications issued by the chief inspector.

The meeting saw a consensus view to convene a roundtable which AYJ will coordinate. The group will also reconvene to ensure ongoing monitoring and action against the concerns raised.

As advised in last month's bulletin, the AYM Executive wrote to Ed Cornmell, Executive Director of the Youth Custody Service, following his update on work being undertaken in the youth secure estate. In the letter we advised Ed of our concerns regarding the potential to propose to ministers that PAVA be used in the youth secure estate.

Alan Webster, the Deputy Director of Youth Justice Policy at the Ministry of Justice has written to the AYM about the changes to high end youth community sentences and the pilot taking place to encourage their use as an alternative to custody.

The ILM Level 7 Certificate programme in Leadership and Management is for individuals who are, or aspire to, senior leadership roles within public sector organisations. Youth Remand Funding

Consultation Now Open



The Ministry of Justice (MoJ) has opened a consultation regarding the youth remand funding arrangements for local authorities in England & Wales; and high-level options for the future.

The consultation outlines the current system of youth remand funding and asks for views about how future funding can be used to meet the youth justice system's aim of preventing offending and reoffending by children and young people. The consultation is aimed at local authorities, youth justice services and others working with children in the youth justice system in England and Wales.

The consultation states that the MoJ's

'assessment of the remand funding concludes that the funding arrangements have not, as designed, directly incentivised investment in alternatives to custody which can be effective in rehabilitation and the prevention of crime. The options for reforming the remand funding outlines high-level reform options which might support our aims of enabling community alternatives to custody and reducing offending.'

The MoJ is seeking views on 'four broad themes': •

- Make no change;
- Change how funding is allocated (including a regional approach);
- > End the funding model and set up a central funding pot into which areas can bid for remand-related initiatives; or
- ➤ End the funding to local authorities and put funding to a different use to improve youth justice-related outcomes.

The consultation document details the options within the policy context:

'wherein local authorities will continue to cover the costs of custodial remands and transport to the secure estate, and remanded children will retain looked-after status. We will not reform the funding model in this financial year and do not plan to make changes prior to the 2025/26 financial year. We will pilot a regional approach to pooled youth remand funding over two years as part of this work.

Pain Induced Restraint

HMPPS and YCS Issue New Policy

HM Prison and Probation Service and the Youth Custody Service (an executive agency sponsored by HMPPS) have issued a new policy 'Use of Force, Restraint and Restrictive Practices in the Children and Young People Secure Estate (CYPSE) which will be implemented on 5th February 2024.



The policy states:

'It is never acceptable to deliberately cause pain when a non-painful alternative can safely achieve the same objective. However, there may be incidents where the risk to the child themselves, other children, members of staff or visitors to the secure setting child is such that there may be risk to their life or that they might suffer serious physical harm or life changing injury and there may be no other viable way for staff to respond to the incident and protect those who are involved.'

The policy requires all incidents of pain induced restraint to be recorded with reasons for its use, and reported to the Youth Custody Service, advising that a:

'Full and thorough review must be undertaken locally, including referral for an independent review if that is available, and any recommendations and learning must inform future practice. In YOI and STC, instances where these techniques are used will also be reviewed by members of the Independent Restraint Review Panel'.

The use of wrist restraint and handcuffs for different scenarios is also covered. In terms of their use as a risk reduction measure, these can only be applied whilst the child is in a standing position. However, where they are being used to support restraint, they can be applied to a child in the standing, prone, kneeling and supine positions. The policy states that:

'Any use of wrist restraints or handcuffs in response to the behaviour of a child must be treated as an instance of use of restraint or physical intervention and the same consideration about whether it a reasonable, necessary and proportionate response will apply.

Where a child is continuing to be non-compliant during a prolonged incident where restraint or physical intervention is underway, wrist restraints may be preferable to using other methods to aid control, movement, or relocation such as if it is necessary to relocate them from one part of the setting to another.

The policy advises, 'Staff wearing BWVC must record the events leading up to the use of wrist restraints and must not switch off the recording until the incident is fully resolved.'

The AYM and other organisations have long called for the cessation of pain induced restraint and recently called for the use of PAVA spray, attack dogs and flash bombs to cease being used to manage children's behaviour in the secure estate. Whilst we therefore welcome reducing the use of pain induced restraint to emergency use only, we would wish for this to be

further reviewed to remove its use completely, alongside the use of these additional methods of control.

Youth Diversion and SEND

Your Views are Needed!

The Centre for Justice Innovation is undertaking a research project, funded by the Hadley Trust and the Esmée Fairbairn Foundation, to explore the responsiveness of youth diversion to children with special educational needs and disabilities (SEND).



The over-representation of children with special educational needs and disabilities (SEND) has been highlighted as a significant challenge for the youth justice system. Evidence shows that 71% of children sentenced in 2019/20 had speech, language and communication needs. As a gateway out of the formal criminal justice system, diversion could prove key in addressing this overrepresentation.

The research project is exploring how diversion delivery works for children with SEND.

The focus of the research is on diversion as defined by the Youth Justice Board:

'Diversion is where children with a linked offence receive an alternative outcome that does not result in a criminal record, avoids escalation into the formal youth justice system and associated stigmatisation. This may involve the YJS delivering support / intervention that may or may not be voluntary and/or signposting children (and parent/carers) into relevant services. All support should be proportionate, aimed at addressing unmet needs and supporting prosocial life choices.

Such diversion usually results in a community resolution (Outcome 8) or no further action diversionary outcome (Outcomes 21 or 22).'

The researchers are asking for the help of those involved in diversion to provide support to understand diversion in practice.

Your insights will feed into the final report of the research which the CJI hope will help enhance children's access to and engagement with diversion.

Providing 'Right Care, Right Person' Responses

Moving away from police responding to mental health crises

During the past year's there have been widespread concerns regarding the over-use of police to respond to emergency mental health calls. The lack of appropriate training officers receive to respond effectively to such crises, and the circumstances in which they are responding, can sometimes lead to further harm to the individual, such as stigmatisation, inappropriate criminalisation, and in some circumstances death. Further, the harm experienced by individuals has been found to disproportionately impact Black and minoritised communities.



The national roll out of 'Right Care, Right Person' aims to ensure that vulnerable people get the right support from the right emergency services and are attended to by dedicated health professionals, facilitated by partnership working with the police.

The Centre for Justice Innovation (CJI) is holding the second in its 'Expert Voices' series to discuss, in a 40-minute introduction to the topic of moving away from police responding to mental health crises, two alternate models from the UK and the United States of America.

Chief Superintendent Tracy Bradley, from Humberside Police, is the 'Right Care Right Person' Lead for the national roll out and will explain how the model operates in practice; giving an overview of how it was implemented in Humberside. She will discuss the approach's success in Humberside, where three years since its implementation, Humberside Police attend an average of 508 fewer incidents, and save 1440 officer hours, each month.

Ebony Morgan, the Program Director for '*Mobile Crisis Intervention*' based in Los Angeles, is a registered nurse with extensive experience working in Mobile Crisis Intervention. Initially working for CAHOOTS, the well-known programme based in Oregon, she now works to help set up other Mobile Crisis Intervention teams across the States. Ebony will share insight on how this model operates and give a background to the situation in the US, touching on why it makes sense to move away from police responding to mental health crises.

The event will be chaired by Claire Ely, Head of Innovative Practice at the Centre for Justice Innovation and there will be time for questions and answers at the end of the session.

Ethnic Disparity in Youth Justice Diversion

Your Help is Needed to Better Understand Causes of Disproportionality

Last month we advised readers of a research project exploring ethnic disparities at the gateway to the youth justice system and the impact of increased use of diversionary mechanisms in that context.

The project, funded by the Nuffield Foundation and undertaken by the University of Bedfordshire and Keele University is now keen to understand the views of youth justice service practitioners and managers to help increase the project's understanding of disproportionality and how it relates to diversionary practice.



Readers will be encouraged to hear that this research is being undertaken; the findings will contribute to youth justice services', and their partners, delivery plans to reduce disproportionality within the youth justice system.

The researchers have sent out a survey to all youth justice services in England asking for it to be completed by the end of September. However, they are keenly aware that many take their summer leave during August and so the AYM is supporting their call to provide information to inform this important piece of research – the biggest and most comprehensive research programmed of its kind.

Joint Targeted Area Inspections

Ofsted, CQC, HMICFRS and HMI Probation have published the framework for joint targeted area inspections (JTAI) of the multi-agency response to serious youth violence. The JTAIs will be undertaken in a sample of local areas from September 2023 to May 2024. The JTAIs of the multi-agency response to identification of initial need and risk will continue throughout this period.

Relentless Pursuit of Criminals



The Home Secretary, Suella Braverman and the Minister of State for Crime, Policing and Fire, Chris Philp have written to chief constables and police and crime commissioners on their shared mission to relentlessly pursue criminals and on improving police visibility and responsiveness.

In the letter the ministers advise that the successful recruitment of an additional 20,000 police officers in England and Wales as a result of the police uplift has led to a record number of officer 149,566 as at 31st March 2023. They are therefore keen to see police confidence increase and for a commitment to investigate all crimes. The ministers write that they were pleased to hear from police organisations that there is now a:

'national commitment to follow all reasonable lines of enquiry for all crime types, and to strengthen police visibility and responsiveness. We understand that no crime investigations will now be screened out solely on the basis that they are perceived as "minor".'

The ministers request that all Chiefs and PCC respond to the letter by the end of September:

'to make clear their plans to improve confidence in local policing and police visibility and share the results of this by March 2024.'

In a further bid to increase public confidence in the criminal justice system, the Prime Minister has also announced government plans to ensure life imprisonment for 'horrific types of murder' results in the imposition of a whole life order, except in extreme limited circumstances.

Ofsted Warn Against the Use of Unregistered Children's Homes

Ofsted has issued new guidance on the need to ensure children are placed in registered children's homes. It advises that children subject to deprivation of liberty (DoL) orders have complex needs and require high levels of skilled care and supervision and that 'too often, these children are placed in illegal unregistered settings without external oversight.'

The inspectorate has issued new guidance, making it clear that settings offering children's home services for children subject to DoL orders should register with Ofsted in England or the Care Inspectorate Wales, advising that the court order does not exempt the provider from being registered and that operating a children's home without registration remains illegal.

Funding to Improve and Increase the Number of Youth Centres

The Department of Culture, Media and Sport has announced that 12,000 young people will benefit from improved youth centre provision that aims to ensure children will have better access to positive out-of-school activities as part of the next phase of the Youth Investment Fund.

This initiative follows the Culture Secretary, Lucy Frazer, setting out her vision for the youth sector, that every young person should have *'someone to talk to, something to do, somewhere to go.'* This new development, costing £70 million, will provide upgrades to existing provision and the building of new youth centres.

The Department also announced it will, boosted by Million Hours Fund, provide an extra night a week of youth work provision until 2026. The National Lottery Community Fund has also confirmed it will match fund the initial Government commitment of £11 million for the Million Hours Fund bringing the total to £22 million.

Announced in March this year, the Million Hours Fund, part of the Prime Minister's Anti Social Behaviour Action Plan, aims to ensure that 'hundreds of organisations in areas of high antisocial behaviour incidents can stay open for an extra night a week. The support is now guaranteed until March 2026.'


